

Our highly-regarded Chartered Associateship programme is relevant to everything that's happening in today's financial services industry. It fits the Level 6 apprenticeship standard and combines the unique option of a sector-specific degree.

Apprenticeship streams:

Subject to eligibility, you can use your levy of up to £18,000 per apprentice to fund this apprenticeship.

How our apprenticeships work

- Flexible start dates tailored to your organisation.
- Modules are studied sequentially.
- Minimum numbers to run a 'closed' programme, unique to a single employer, are 10. If you have less than 10, get in touch with us to discuss the possibility of joining an 'open' cohort (with multiple employers).
- A range of delivery options including face-to-face workshops, real-time webinars and supported online learning.

How are your apprentices supported by us?

Personal tutor

- Guiding, coaching and supporting the individual throughout their journey.
- Regular progress reviews, in person and by telephone, between your apprentice, their line manager and our personal tutor.

Academic faculty

- Each module is designed and delivered by our academic faculty, many of whom have extensive practical experience in the financial services industry.
- 1-2-1 contact between apprentices and our faculty by telephone and e-mail.

Programme manager

- A clear point of contact for all apprentices throughout their time on our programme.
